The USS Tahoma and the CSN Bat are ready to take on troops. We have a berth (space) at the show and depending on how many of us respond to this call will define what we can do at the show.

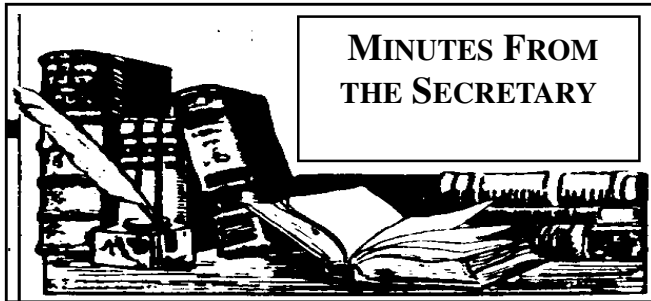

WCWA Board of Directors Meeting Minutes
January 15, 2011
G. A. R. Cemetery, Snohomish, WA

I. Call to Order. Meeting was called to order at 10:18 by Chairman Al Myers.

II. Roll Call was made by Secretary Kevin Saville. All Administrative Board members were present except Tobey Gulley who was represented by Marc Williams.

For the General Board, on the Federal side, there were seven unit representatives and three proxy representatives present (ten total). On the Confederate side, there were four unit representatives and no proxy representatives present (four total). Total eligible representatives was 14 out of 28 total. A. Myers said this is the beginning of a new year so every unit representative should be a current member of the WCWA. One Federal proxy representative was not counted due to the issuing commander not being a current member.

III. Secretary's Report was made by Kevin Saville. There were no November 2010 meeting minutes due to that being an unofficial meeting due to lack of quorum. The October 2010 meeting minutes were published in the November Dispatch and could not be approved in November. There were no changes to the October meeting minutes; they were approved as read. A. Myers asked if people got the January Dispatch; it was mailed Thursday 1/13. It is on the webpage now.

IV. Treasurer's/Membership Report was given by Treasurer Anna Flores. The Harvest Ball concluded with the room deposit being returned; the event paid for itself with \$70 income. In regard to major events, Ft. Steilacoom suffered a loss of \$2,900; Spokane had an income of \$3,600 but no portapotty bill was submitted. Port gamble was \$3,600 to the good; Hovander suffered a \$2,900 loss.

John Strand indicated that Steilacoom broke even but there is a loss due to a new insurance charge policy in the WCWA. Flores said without the insurance cost of \$2,000, Steilacoom still would have lost \$800-900. She explained that it is easier to divide insurance between sponsored events than to include sanctioned events. The cost was \$2,060 per sponsored event for insurance and we hope event incomes will cover their insurance expense. Flores added that if you are doing a sanctioned event, you are obligated to reimburse the WCWA for insurance at a rate of 10% of income.

V. Brigade Commanders Reports

Marc Williams said T. Gulley apologized for his absence. Marblemount is firmed up for April 16 & 17.

VI. Committee Reports

A. Event Planning & Activities

Howard Struve said if you have a webpage for your event, please update it for this year. People want to have the latest and greatest information available for upcoming events. There is still some old information up for last year that doesn't work for this year. If you have questions regarding the WCWA website, please contact Peggy Lange. The 2011 event calendar is on there now.

H. Struve said he got an email from the Tacoma Sportsmen's Club asking if the WCWA would participate at an event there the second weekend of July. Struve said there will be a cost to camp there and July is a busy month. He pointed out that the WCWA insurance policy does not permit members to live fire at insured events. Given the various factors, Howard will reply with a "thanks but no thanks" regarding a TSC event in July unless he hears of considerable interest from the WCWA membership. Bob Ballard asked if anything is going on with a Roy event. Struve said that event will not be this year.

B. Living History. No report.

C. Outreach. No report.

D. Publicity. No report.

E. Risk/Insurance

Al Myers reported that insurance quotes are being received from more than one insurance provider. It appears that premiums are sometimes based on the number of events and sometimes on the number of members; some providers use one or the other or both criterion. He emphasized that there must be a

repercussion for someone going on the field that's not a paid member. We cannot afford to have a nonpaid member on the field in case something happens. Discussion led to guest members that do not actually pay their membership dues to the WCWA and that are not a member of an organization with which the WCWA has a reciprocity agreement.

David Imburgia said the insurance company doesn't care about the membership dues amount each member pays but rather cares that every participant is a member and that every participant has completed safety training and taken a safety test. Having completed membership forms and completed safety training/testing for every participant (other than reciprocal agreement participation) is what's important. A number of meeting attendees suggested that the cost of annual membership is similar to the cost of participating in an east coast, or other, event. **Nathan Alred moved that visiting reenactors must be required to pay the regular annual WCWA membership fee if he/she is not a member of an organization with which the WCWA has a current reciprocity agreement. Bob Ballard seconded the motion. Following discussion, the motion passed with 12 in favor and two abstained.**

A. Myers indicated that changes need to be made at events to prevent people that have not paid and not submitted their membership form from participating at a given event. Much discussion followed with various suggestions put forward to address the problem. A. Myers said something needs to be put in the Bylaws (to permit only members and reciprocity holders to participate). Please consider this topic as it will be addressed at the next meeting.

VII. Unfinished Business. There was none.

VIII. New Business

A. Online Dispatch. A. Myers asked if the Dispatch should continue to be offered as it is, both online and by mailed hardcopy to those requesting it. Some members have suggested that it should only be offered online. A. Flores reported that in 2010, \$3,900 was spent to send 200-250 hardcopy Dispatches via U.S. Mail. Postage was \$936 and the remainder was printing cost. Discussion ensued with various positions being offered on the matter. The Dispatch essentially costs approximately \$15 annually, per member/household, to send via U.S. Mail. Some people can

only access the hardcopy version. Some lifetime and honorary members should be receiving the Dispatch hardcopies. It was also pointed out that information needs to be timely with regard to events; the burden was placed squarely on event coordinators to get information submitted two months in advance of their event. Al said the Dispatch editor plans to get each month's edition out at the first of the month. **Bob Ballard moved to have an annual \$5 surcharge for the printed and mailed hardcopy of the Dispatch. This will be voted on at the February meeting.**

B. General Member Meeting. A. Myers asked where we should have the general board meeting. There was discussion of a location in Eastern Washington. Bonnie Starr said we have had the meeting on the east side and attendance over there was worse than over here. Howard said the event schedule lists the meeting in February. Al said the General membership meeting will be here at the Snohomish GAR cemetery on February 19. C. Quorum. A. Myers said he cannot find in the Bylaws or Constitution how many voting representatives constitute a quorum. Discussion followed. **B. Ballard moved that the quorum be defined as one third of the eligible unit commanders, including proxies. That was seconded by N. Alred.** Discussion followed regarding the lack of participation at board meetings. A. Myers said he has considered having a conference call with the east siders. Others indicated general trends are toward an apathetic attitude with poor attendance at all but the major battle events. **J. Strand later moved that if the one third motion fails, the WCWA quorum should be set at 50% plus one, including proxies. This motion was seconded. (The 50% motion is more restrictive and, as such, may be more or less appealing to some people.)**

D. Sesquicentennial. Rusty Starr presented information from the Washington State Sesquicentennial Organization for the Presentation of the American Civil War. Two meetings have been held, to date, at the Chehalis Veterans Memorial Museum. The State of Washington is not really doing anything for the Civil War Sesquicentennial. MOHAI was going to, but that museum in Seattle will probably disappear due to bridge relocation. The Tacoma history museum is going to do a one day event but so far they haven't contacted anyone.

R. Starr reported that The Washington Veteran's Museum in Chehalis will hold two Civil War events

this year: April 16 and July 16. The April event will include much information about the war's causes and will go through Fort Sumter. The July event will get into the war and focus on Second Bull Run. During the next four years, there will be different events for the subsequent 150th time periods. These are to be strictly education presentations; there will be no battle reenactments. They will make reference to, and publicize, WCWA events with links to our website and references to the WCWA in news media. Most displays will be inside; outside displays will be on asphalt/pavement unless an adjacent field becomes available. Bonnie Starr requested unit brochures and the books that she compiled a few years ago on WCWA unit histories. Please contact Bonnie if you know the location of those books. Rusty explained that they want reenactors there to participate but participants need to be knowledgeable of the war and educate the public. They do not want "collectors" that mostly show stuff that they've collected; a collector mentality is unacceptable.

The April 16 Veteran's Museum event conflicts with Marblemount; however we are committed as a club to both events. The Veteran's Museum days will be one day events on Saturdays only with public participation between 9 a.m. and 4 p.m. **Anyone that is interested in participating on either April 16 or July 16 at the Chehalis museum, please contact Rusty or Bonnie Starr before March 6.**

E. Fort Lewis 2010 income. A. Flores said she has money from Fort Lewis that has not been distributed to participant companies, in part because some Civil War participants were not members. Please contact Anna or the event coordinator (Shelly Butterfield) if you think money is due from Fort Lewis.

IX. For the Good of the Order

A. Past Event Reports. There were none.

B. Upcoming Event Reports.

Plain Event. Peter Jensen described that a Plain event on the first two days of October would have ideal weather and he is planning to co-coordinate the event. A. Myers said this event has been brought up several times at past meetings but no event application has been submitted. Jensen asked for input on whether such an event would get participants; some people indicated they would go. A. Myers requested that an event application be submitted for consideration.

Spring Ball on March 12. Linda Myers said a spring ball is being sponsored by the Mason Dixon Township

(Civilian unit) and it will be held in Steilacoom on March 12. The event registration form is in the Dispatch; Myers asked that unit representatives get the word to their companies about this ball. D. Imburgia said there's a 50-50 chance that the Harvest Ball will be held this year.

New Orleans Filming. Norm Harriman announced that a film proposal has been received for New Orleans. Flight, per diem, and housing will be provided. It will be a four to ten day shooting on camera April 29 to May 7.

Honoring their Memory. Bruce Smith said this year they will be honoring the beginning, as well as the ending, of the Civil War. There will likely be a work party in March to clean up headstones at the Snohomish G.A.R. cemetery where the event is held. Details will be out before the next board meeting.

C. Unit Reports.

2nd U.S. Sharpshooters. H. Struve reported that Derrick Sturgill will be stepping down and Nicky Brown will be taking over as captain. Ethan Whitehall will be 1st Sgt. 26th North Carolina. Nathan Alred is now captain of the 26th N.C. Bill Lewis/Dirtywater's clone, Leo, is now 1st Sgt.

D. Announcements. There were none.

X. Adjournment. Meeting was adjourned at 12:17 p.m.

Next Meeting (a General Board and Annual Membership Meeting) is Feb 19, 2011 at the G.A.R. Cemetery hall.

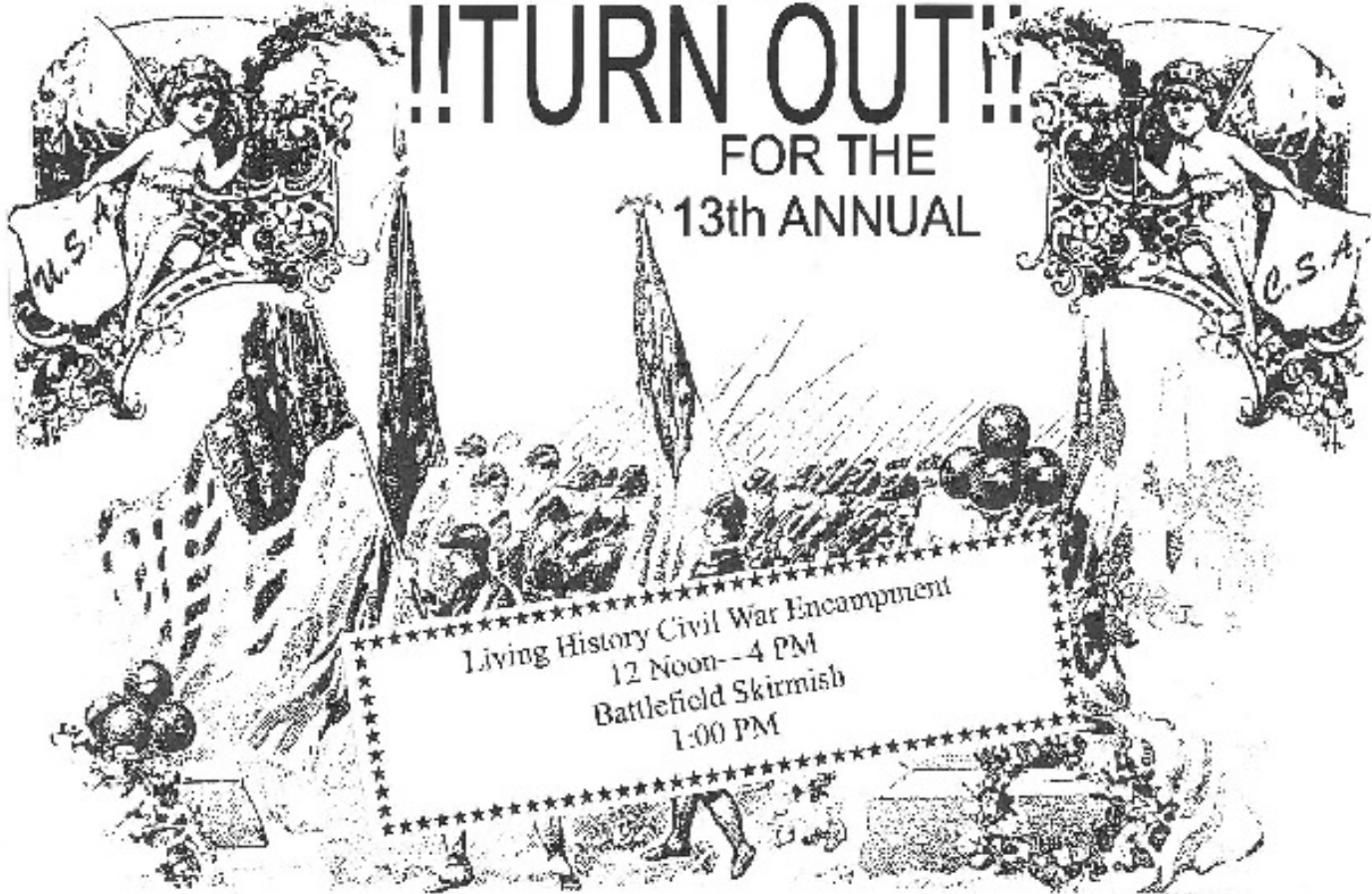

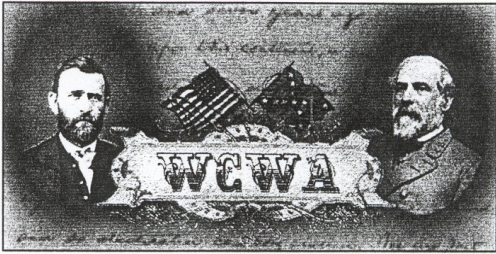
